Elections Committee appointment

Renee Freeman-Butler, recently retired HEO at LaGuardia Community College, has been recommended by the Executive Council for approval by the Delegate Assembly to serve on the PSC Elections Committee.

MOTION: To approve Renee Freeman-Butler's appointment to the PSC Elections Committee (Motion: Executive Committee) **APPROVED.**

CUNY budget

The Senate and Assembly one-house budgets have allocated additional resources for CUNY above the Governor's executive budget. Both reject the Governor's proposed 3% tuition increase and restore funding for critical student programs such as SEEK, the Black Male Initiative, mental health counseling, and childcare centers. New investments in graduate education, nursing, and state aid to community colleges appear in the one-house budgets. However, the NYC budget for CUNY must be improved substantially to avert catastrophe at the community colleges, as Mayor Adams has proposed additional cuts for FY2024 and larger cuts thereafter. Management has demanded that every college submit and implement "savings plans" of 5-7% for FY2024, in anticipation of the end of federal stimulus and low tuition collections due to enrollment declines. The PSC is pushing back against these demands and organizing protests to fight for full funding for CUNY.

KCC incident and follow-up

The incident at KCC involved a confrontation between students over an alleged racist epithet that was escalated by the NYPD when KCC campus security called them onto campus. A young African American man was physically restrained on the ground, arrested, and charged. The KCC chapter chair initially reported that the student was immediately released from police custody and the college did not bring disciplinary charges against any students connected with the incident. However, it was later revealed that the administration misled the PSC chapter leadership and the rest of the campus community, and disciplinary charges were in fact brought against students. A group of concerned KCC faculty circulated a sign-on letter challenging the administration's handling of the incident. The PSC Executive Council plans to meet with the KCC chapter leadership and representatives from the PSC Anti-Racism Committee to hold the KCC administration accountable and develop resources and guidelines to prevent incidents of racism and over-policing on campus.

NYC health insurance/Medicare Advantage

The Municipal Labor Committee has approved the Aetna City of New York Medicare Advantage (MA) plan for retirees and their Medicare-eligible dependents, which will replace the GHI Senior Care plan starting from September 1. PSC Retiree chapter and some member unions are advocating for the preservation of cost-free Senior Care or a public Medigap plan. However, preserving these benefits would undermine the fiscal savings achieved by the MA plan. PSC leaders are calling for a stakeholder's commission to address the structural problem of rising health care costs to the city and advocating for a nationwide single-payer health program. The opt-out period for the Aetna MA plan is scheduled for May

1-June 30, and retirees who do not enroll in either of the proposed city-provided free plans will need to purchase Medigap coverage on the open market, losing eligibility for certain benefits. PSC members are encouraged to call in to the public hearing on March 21 and may participate in public demonstrations in the coming weeks.

Contract campaign

The Contract campaign at CUNY has received favorable press hits and several chapters have engaged in local actions with more planned by CATs. A central CAT meeting will be held in early April, and it is important for CAT activists to engage in membership conversations and educational and agitational conversations about initial contract demands. Negotiations with CUNY are ongoing about funds under Appendix O and incorporating language against workplace bullying in CUNY policies and employee training modules.

The Chief Labor Designee and Executive Vice Chancellor for Labor Relations, Pamela Silverblatt, has announced her resignation effective at the end of March.

A. Financial Report - F. Wharton

January 2023 Financial Statement Total Operating Income: \$1,661,000 Total Operating Expenses: \$1,452,000 Surplus (Deficit): \$209,000

Year-to-date (5 months): As of January 31, 2023, the financial statement shows a five-month surplus of \$259,000 when year-to-date expenditures are compared with year-todate income. PSC spent \$8,062,000 and \$8,321,000 was received over the fivemonth period.

B. Executive Directors Report - D. Hubbard Elections committee update: A. Delegate Assembly Lucy McIntyre was elected as Cross-Campus Officer at the February 16, 2023 DA meeting. She took office March 10, 2023.

Two candidates were nominated at the February DA meeting for the vacancy in the position of Part-Time Personnel Officer, Marc Kagan and Claudia Schachter deChabert. The candidates did not agree to hold a staff-run election at the February DA meeting. With the agreement of the candidates, the Elections Committee arranged for the AAA to administer the in-person portion of the election at tonight's DA meeting, and for PSC staff to administer the online portion of the election at this meeting.

B. Individual Chapters

On February 27, Lisanette Rosario resigned as a HEO Chapter delegate. The vacancy was recognized by the elections committee on February 28.

C. Central Union Administered

The Spring 2023 chapter elections are under way. The nominating petitions were distributed on Monday, February 6, 2023, and the deadline to receive nominating petitions passed March 6, 2023. Here is the remaining part of the timeline:
