# II. President's report and discussion (including written) - J. Davis

Spring Meeting Schedule DA Meetings, Thursdays 6:30 January 18 February 15 March 21 April 18 May 23 June 20 MOTION: To accept Delegate Assembly meeting dates for Spring 2023 (Motion: C. Shacter-DeChabert; seconded) APPROVED.

President Davis acknowledged the achievements of various chapters and committees. He also discussed the struggle for academic freedom and the work done by the PSC Academic Freedom Committee, expressing gratitude to all members for their activism and emphasizing the importance of solidarity.

### **Contract Negotiations and Campaign**

President Davis introduced a slide show of highlights from the PSC's successful December 2 rally. He discussed the status of contract negotiations and the need to increase pressure on management. CUNY has delayed scheduling additional negotiating sessions and the union intends to use inflection points in the spring semester, like the one year anniversary of the expiration of the contract, to intensify the pressure on management. There are plans for civil disobedience trainings, workshops on the Taylor Law, and collaboration with the Revenue Coalition. The launch of the legislative campaign to make Columbia and NYU pay their fair share of property taxes was announced.

### Membership - A. Vasquez

Andrea Vasquez provided an update on membership. She encouraged delegates to continue to sign up to do walkarounds with organizers, and she emphasized the importance of one-on-one conversations and building support for membership work among more members. There will be upcoming trainings and delegates are encouraged to actively engage in membership conversations.

### Adjunct Liaison Leadership Program - P. Lewis

Penny Lewis explained the reforming of the liaison program, including the launch of the Adjunct Liaison Leadership Program and the goal of having more mentors and rotating positions. The liaison program had historically focused on getting new members, and liaisons functioned too much like staff in the union, which is against the union's constitution. There had not been much intentional development to bring liaisons to be leaders on campus. Over the past two years, a number of staff and EC members, including current and former liaisons, reviewed the program and reconstituted it as more of a leadership development and training program in line with other leadership development the union does. Instead of a long-term position, it will be one to two years, and more adjuncts will go through training. The goal was to have 6 mentors and each working with 2-3 liaisons each; it is the hope of the EC that the numbers participating will grow. The idea is to have those stepping down from liaison still be active and guiding people into membership and union work. This would not be a paid staff-like position but participants receive stipends while doing the leadership development and mentoring. It's a work in progress and will be actively reviewed as it is underway.

We, members of the American labor movement, mourn the loss of life in Israel and Palestine. We express our solidarity with all workers and our common desire for peace in Palestine and Israel, and we call on President Joe Biden and Congress to push for an immediate ceasefire and end to the siege of Gaza. We cannot bomb our way to peace. We also condemn any hate crimes against Muslims, Jews, or anyone else.

In issuing this call, U.S. unions are joining the efforts of 13 Congressmembers and others who are calling for an immediate ceasefire.

*The basic rights of people must be restored.* Water, fuel, food, and other humanitarian aid must be allowed into Gaza, power must be restored, and foreign nationals and Palestinians requiring medical care must be allowed out of Gaza.

*The Israeli hostages taken by Hamas must be immediately released.* Both Hamas and Israel must adhere to standards of international law and Geneva Convention rules of warfare concerning the welfare and security of civilians.

*There must be a ceasefire in Gaza.* The cycle of violence must stop so that negotiations for an enduring peace proceed.

The U.S. must act. We call on President Biden to immediately call for a ceasefire.

The road to justice cannot be paved by bombs and war. The road to peace cannot be found through warfare. We commit ourselves to work in solidarity with the Palestinian and Israeli peoples to achieve peace and justice.

Union members come from diverse backgrounds, including Jews, Muslims, and Middle Eastern communities. The rising escalation of war and arms sales doesn't serve the interests of workers anywhere. In the end, we all want a place to call home and for our children to be safe. Working people around the world want and deserve to live free from the effects of violence, war and militarization.

Thousands of Americans have joined the groundswell of global solidarity demanding a ceasefire now.

It's the labor movement's turn to make our voices heard and demand a ceasefire. Together, we can stand for peace, justice, and a better future for working people everywhere.

# **Resolution to condemn the leadership of the AFL-CIO and the AFT for its complicity with the genocide of the Gazan masses and the Palestinians in general**, Submitted by Carol Lang, BCC

Be it resolved, that the PSC opposes the genocidal behavior of the Israeli government, and understands that this is not a two-sided war, but one of extermination, and that the members oppose buying bonds from the Israeli government and that we oppose our tax dollars, which amounts to \$3.3 bn that our government is sending to Israel yearly;.

Be it resolved, we support the Palestinians call for an immediate ceasefire, but what is needed is a the halt altogether to Israel's war and that we support the defense of the Palestinians and the equality of the Palestinian and Jewish workers who have no reason to compete with each other;

Be it resolved, we support the Palestinians right to defend themselves in the face of such genocidal behavior of the Israelis;

Be it also resolved that the union leadership must defend the rights of workers to free speech and oppose any doxxing that is happening to our members and to people around the country who are being harassed by rightwing fanatics;

Be it further resolved that the AFT stop buying Israeli bonds;

Be it further resolved that this resolution be raised in all the bodies of labor, AFT, AAUP, NYSUT, CLC, and in the AFL-CIO as well and where possible we encourage dockworkers to hotcargo weapons going to Israel and call for the embargoing of Israeli ships. **MOTION**: To pass the resolution (Motion: C.
