Pursuant to a letter of agreement dated January 14, 2020, with Barbara Gabriel of Professional Staff Congress City University of New York- York and York Welfare Fund (“York WF”), hereinafter referred to as “PSC CUNY,” the American Arbitration Association hereinafter referred to as the “Administrator,” agreed to conduct an Election of Officers.

Four Hundred Seventy-Two (472) ballots were mailed to eligible York voters and One Hundred Twenty-Two (122) ballots were mailed to eligible York WF voters on Wednesday, April 1, 2020. PSC CUNY provided the Administrator with a list of persons who were eligible to vote. To be counted, ballots had to be received by the Administrator no later than 5:00 P.M. on Thursday, April 30, 2020.

The Administrator received a total of Seventy-Five (75) York ballot packets and Ten (10) York WF ballot packets by the deadline scheduled. The counting of the ballots took place on Monday, June 8, 2020, at the offices of the Administrator and in the presence of virtual observers.
